

Community for New Direction, Inc.'s mission is to reduce the use and abuse of alcohol, tobacco, and other drugs by program youth, and to decrease the number of youth violent acts of crime, especially related to drugs.

Prevention Program - The prevention program provides academic support and leadership development training for children throughout their school career, even during summer vacation and as they make their way to college and the job force. Many of the students we serve are part of our services from kindergarten to graduation. CND prides itself on being responsive to community needs, serving the inner city, and collaborating with schools in economically distressed neighborhoods in order to achieve its purposes.

4b (Code:) (Expenses \$ **710,822** Including grants of \$) (Revenue \$ **720,890**)

Mental Health and Substance Use Disorder Program - CND offers comprehensive substance use disorder and mental health treatment programs licensed by the Ohio Department of Mental Health and Addiction Services. Treatment services include non-intensive outpatient and intensive outpatient programs including Medically Assisted Treatment. Services are provided to adults 18 and over who qualify. Clients include the parents of CND students, court-mandated clients, walk-ins at our local offices and referrals from the community. CND employs five clinical staff and contracts with two area doctors and bills Medicaid and private insurance for program service cost. In addition, CND offers a special program for Native Americans operated in conjunction with the staff from the Red Bird Center.

Recovery Residence - CND opened a Level III Recovery Residence in Franklin County as part of the continuum of care for our Mental Health and Substance Use Disorder program. Our Recovery Housing serves 5 residents in the process of recovery from substance abuse disorders. The house provides a living environment free from alcohol and illicit drug use with a focus on peer support and support services which include life skill development such as budgeting and employment skills from staff who are Certified Ohio Peer Recovery Coaches employed by CND.
