The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. On December 31, 2020, there were no material unrecognized tax benefits identified or recorded as liabilities.

The Agency files Form 990 in the U.S. federal jurisdiction and the state of Ohio. The Agency's federal exempt organization tax returns are subject to examination by the Internal Revenue Service, generally for three years after they are filed.

Clients include the parents of CND students, court mandated clients, walk-ins and referrals from the community. All services are billed to Medicaid, private insurance and our local ADAMH board. In addition, CND offers a special program for Native Americans operated in conjunction with the staff from the Red Bird Center.
